

- 1. The Sprinterfest Perch Fishing Derby will take place on Saturday, April 24, 2021 from 10:00 am to 4:00 pm. Participants must be inline by 4:00 pm. Check in on the day of the event begins at 8:00 am.
- 2. The measuring will occur at Walter & Mary Burke Park in Downtown New Baltimore (36300 Front St.) inside the measuring tent.
- 3. Contest fish species is the Yellow Perch. The longest length wins, tie breaker is the perch with earliest time of entry. All perch must be entered alive. A bigger perch may be entered by contest closing. Perch can be submitted for minors on behalf of a related relative. Yellow perch must be more than 7 inches in length as per DNR Rules to harvest and enter.
- 4. Register fee and age brackets are as follows: \$15/ registrant at the adult level (18+), \$5 for Junior (11-17, boys & girls), Free for Kids (10 and under, boys & girls).
- 5. The boundary waters: Waters from Blue Water Bridge to the northern tip of Belle Isle in the Detroit River and waters connected to Lake Saint Clair. Off limits are any ponds, inland lakes, any Canadian Waters, the Detroit River south of the Belle Isle northern tip, Lake Erie, and Lake Huron.
- 6. The person entering the fish must declare division (adult, junior, kids) the fish is to be entered and may not change after the declaration.
- 7. Once perch are entered they will be displayed until the end of the event, anglers can return by 4:30 pm to pick up, after that the fish will be forfeited.
- 8. All Michigan DNR fishing rules apply. No dead fish can be entered or returned to the water.
- 9. By entering this event you are giving your permission to have participants likeness reproduced on film, camera, TV, video, audio, text, social media, print, or on other promotional materials.
- 10. All fish will be checked by derby committee and all decisions made by the event officials are final. All prizes must be accepted as awarded and have no other surrender value
- 11. This is a fishing contest and unfavorable actions, vulgar language, obscenities, via in person, at the contest or afterwards, via text, email, or social media will not be tolerated, and participants will be disqualified. It is the intention of the volunteers to host an honest event.
- 12. The organizers reserve the right to amend, add to, remove, or otherwise change any of the rules and regulations for this contest, without prior notice, if it is deemed by them to be in the best interest of all parties involved in the derby. The contest organizers reserve the right to refuse any applications or registration.
